Each eligible property owner can apply for up to two (2) free street trees (15-gallon size). Trees must be planted in the front yard of the property and be chosen from the list of approved trees that can be found at www.ourcityforest.org/el_quito (if you do not have access to the web, we will mail you a list). All ordering logistics, planting and code compliance will be handled for you- all you have to do is agree to care your new free tree over the next three years. The El Quito Neighborhood is specifically bound by Saratoga Avenue, Quito Road, and Highway 85 (excluding the Bellgrove housing development). Here is what you can expect from Our City Forest

Our City Forest has been contracted by the City of Saratoga and the El Quito Neighborhood Association to provide the following services using the El Quito LLD funds and at no additional cost to the property owner.

- 1. Oversight of the tree planting process by a certified OCF arborist
- 2. Review and record tree application
- 3. Assess tree selection and confirm planting site meets all city code requirements
- 4. Planting site inspection
- 5. Tree species selection confirmation
- 6. Procurement and delivery of 15-gallon tree from approved nursery using California Department of Forestry specification
- 7. Staking with one Reddy stake or two wood stakes
- 8. Underground service alert coordination with Utilities prior to excavation for utility identification and protection
- 9. Site preparation and soil amendment as needed
- 10. Tree and stake installed to specifications
- 11. Watering basin development and initial watering at time of planting
- 12. Post planting inspection at 6 months, 18 months and 3 years
- 13. Stewardship update forms and reporting at 6 intervals over the three years
- 14. Provide general pruning instructions to each applicant; perform final structural pruning service at 3 years
